## HECKER VILLAGE BOARD MINUTES May 12, 2015

## Mayor:

- Mayor Kujawski reported that the new truck is ready to be picked up. Charlie Kujawski and Brice Griffin will pick the truck up on Friday, June 15<sup>th</sup>.
- Mayor Kujawski explained that the appointed trustee only wanted the position for two years. At that time, three other trustees will be up for re-election. There will be three 4 year terms and one 2 year unexpired term available at the next election.

## Committee Reports:

- Cemetery—Discussion again was held concerning the decorations put at the grave sites.
- Public Works—Discussion was held on continuing with the Water Station Project. Still waiting to hear back from a property owner on leasing a part of his property for the project.
- Parks & Recreation—The new tetherball is in place at the park. Trisha will get prices for mulch for the playgrounds.
  - The town-wide yard sale will be held on June 5-6.
- Streets—Discussion was again held on the Drainage Project at Freedom Village
- Zoning—Guy Briley stated that a registered letter was sent to the owner of the property at 120

Bids were received from Deterding Tree Service and R & N Outdoor Service for the removal of a tree on West Monroe St.

A bid of 600.00 was received for sidewalk removal on E. Back St. Gary Wittenauer made a motion seconded by Trisha Maddox to approve the bid for sidewalk removal on E. Back St. Voting 3 yes and 1 absent, motion carried.

Gary Wittenauer made a motion seconded by Rich Happel to adjourn the meeting. Voting all ayes, motion carried.
