HECKER VILLAGE BOARD MINUTES

December 8, 2015

President Charles Kujawski called the November 10, 2015 regular Board Meeting to order. Douglas Van Buren was absent.

Trisha Maddox made a motion seconded by Gary Wittenauer to approve the November 10, 2015, Regular Board Minutes. Voting all ayes, motion carried.

Arnie Eckart made a motion seconded by Jim Mueth to approve the Treasurer's Report and pay all bills submitted for the month of December. Voting all ayes, motion carried.

Mayor:

- President Kujawski will post a notice of Village Board Meeting Dates for the 2016 year.
- As Liquor Commissioner, President Kujawski has approved the liquor license for the Hecker Community Center and Backstreet LLC.

Committee Reports:

- **Cemetery**—Someone voiced their concern over three different lots at the cemetery that are sinking. The area will need to have more fill dirt and will need to be re-seeded.
- Police—The new contract for policing with Monroe County will be voted on at the next meeting.
- Public Works—The lease agreement for the Bulk Water Station was discussed.
 - Arnold Eckart made a motion seconded by Rich Happel to accept Resolution 15-009 The Lease Agreement for Land with Walter and Alice Krysnoski. Voting 5 ayes and 1 absent, motion carried.
 - **2.** A quote from Schulte Supply for the equipment for the Bulk Water Station was looked over.
 - Arnie Eckart made a motion seconded by Trisha Maddox to approve the quote from Schulte Supply for the equipment for the Bulk Water Station minus the card option. Voting 5 ayes and 1 absent, motion carried.
 - 3. Bid specs from TWM were reviewed.
 Rich Happel made a motion seconded by Jim Mueth to have TWM move forward with the bid specs. Voting 5 ayes and 1 absent, motion carried.
 - 4. The new contract with FSH Water was also reviewed.
 Rich Happel made a motion seconded by Gary Wittenauer to approve Resolution 15-010 FSH Water contract. Voting 5 ayes and 1 absent, motion carried.
- **Streets**—Projects for the Motor Fuel Tax program were discussed. One item to be done is to oil all the streets on the west side of Rt. 159
 - 1. Arnie Eckart made a motion seconded by Trisha Maddox to approve the 2016 Motor Fuel Tax Budget. Voting 5 ayes and 1 absent, motion carried.
 - **2.** South Nike St. Ditch work and North Orchard Lane work was discussed. More concrete work will need to be done on North Orchard.
- Zoning—Nothing to report at this time.
