Committee Reports

- **Police**—Monroe County Sheriff's office said to report anything that looks suspicious at any time.
- **Public Works**—Haier Plumbing has ordered the building for the Bulk Water Station.

Discussion was held on installing an alarm system at the sewer plant.

- Streets— Freedom Village Drainage Project—A letter will be sent to Thor Lohrberg asking him to meet with the mayor to discuss what plans he would like for the drainage issue.

 Stop signs and speed limit signs are being replaced with new ones.
