Mayor:

- Mayor Kujawski reported that there will once again be a Halloween Party on Monday, October 31 from 5:00pm-6:15pm at the Hecker Community Center. There will be games, food and costume judging. Judges still need to be appointed.
- The Village needs to put together a time capsule filled with items from Hecker. The churches will be contacted to put something in as well as newsletters and pictures from the Village. This needs to be done by November 5.
- The Bi-Centennial Gala will be held on November 5, 2016.. Arnold Eckart made a motion seconded by Gary Wittenauer to purchase 4 tickets to the Bi-Centennial Gala. Voting all ayes, motion carried.

Clerk:

Committee Reports:

- Parks & Recreation: Trisha asked the Board what type of budget she has to work with to add and update the equipment at the park. At this time she has a budget of \$3400.00 to work with and was asked to get a number together before the next fiscal year budget is put together.
- Cemetery: A discussion was held on some concerns of the overall appearance at the cemetery.

- Sewer: The Village is looking into removing the Hecker Community Center from their Ameren bill and receiving their own. Visu-Sewer will be doing smoke testing on the sewer lines late September early October.
- Streets: The work on North Orchard is completed except to do some seeding.

October 3 is the date set to do the next round of Oil and Chipping to the area west of Rt. 159. Estimated cost for the oil and slag is \$12,000.00.

Rich Happel made a motion seconded by Gary Wittenauer to contract either Baxmeier or Hanks Excavating to do grading in the 200 Block of W. Washington up to \$7000.00. Voting all ayes, motion carried.

Street sweeping will be done on September 19.

There have been drainage issues reported at 150 E. Lincoln in Country Village.

Zoning: The issue of the car lot was again discussed.
