## HECKER VILLAGE BOARD MEETING January 8, 2019

President Charles Kujawski called the January 8, 2019 regular Board Meeting to order. After reciting the Pledge of Allegiance, the following members answered roll: Charles Kujawski, Rich Happel, Jim Mueth, Trisha Maddox, Arnold Eckart, Douglas Van Buren, Gary Wittenauer, Guy Briley, Lori Amann and Annette Schreder.

Gary Wittenauer made a motion seconded by James Mueth to approve the December 11, 2018 regular Board minutes. Voting all ayes, notion carried.

Rich Happel made a motion seconded by James Mueth to approve the treasurer's report and pay all bills submitted for the month of January. Voting all ayes, motion carried.

Mayor: Reported that the Jetter machine for sale by the Village sold for \$600.00. President Charles Kujawski also reported that he was told the bid received last month from Equipment Service Co. Inc. was not the right piece of equipment. The bid will be \$500.00 more making the bid at \$2570.00. Discussion was held on what decision should be made. It was decided to ask about a break on the labor costs.

Douglas Van Buren made a motion seconded by Rich Happel to discuss the labor fee with Equipment Service Co. and if no change on the labor cost, the Village will install the spreader itself. Voting all ayes, motion carried.

Dustin Blackwell was in attendance and spoke on several issues concern Brauns Milk Hauling. One issue was the condition of Washington St. between Brauns and the Village Park. It has a lot of pot holes and is tore up from the heavy semi traffic. Mr. Blackwell voiced his concern that Braun's should be liable for the costs of fixing the road. The other issue was the parking of derelict semis and other unsightly stuff. He also felt it was a safety hazard because anyone could get onto the property and get hurt. He suggested the need for some kind of fencing that would hide and contain any unused equipment. Discussion was also made about the possibility of putting up a fence on the Village Park property.

Committee Reports:

- Public Works—Visu-Sewer has finished jetting and videoing sewer lines on the west side of Rt. 159. Visu-Sewer said the roots were bad on the line between the Village Hall and Brauns Accounting.
- Parks & Recreation—Trisha Maddox would like to look into getting some new equipment for the park. Also the Community Wide Yard Sale will be on June 7th & 8<sup>th</sup>.
- Streets—James Mueth stated that Dale Haudrich has done some field drain tiling work in hopes it will help with some of the drainage issues between his property and several Village resident's property.
