Committee Reports:

• Water & Sewer: IEPA is requiring additional water testing that will increase the cost to water and sewer. Hydro Services has submitted a proposal showing the cost of the new testing which will go to 5 days a week instead of 3 days. Discussion was held on several ideas such as buying the equipment and doing the testing ourselves and to find other companies who do water testing and get bids from them.

Received an email from HTC concerning the contract for tower usage.

• Parks & Recreation: The Village Wide Yard Sale is set for July 31 and August 1.

Quasquincentennial Committee: The next meeting will be held on July 16, 2020 at 7:30pm at the Community Center.

President Kujawski handed out the new Ordinance for the Revised Sexual Harassment Policy for review.
