

HECKER VILLAGE BOARD MEETING
November 8, 2022

In absence of President Charles Kujawski, board Trustee Arnold Eckart called the November 8, 2022 regular Board Meeting to order. After reciting the Pledge of Allegiance, the following members answered roll call: Rich Happel, Jim Mueth, Aaron Eckart, Arnold Eckart, Douglas Van Buren, Gary Wittenauer, Wade Harrelson, Lori Amann and Annette Schreder. Charles Kujawski was absent.

Rich Happel made a motion seconded by James Mueth to appoint Arnold Eckart as Mayor-Pro Temp in absence of Charles Kujawski. Voting all ayes, motion carried.

Gary Wittenauer made a motion seconded by James Mueth to approve the October 11, 2022 Regular Board Minutes. Voting all ayes, motion carried.

Appointments: Village President has appointed Gary Wittenauer as the representative to the FSH Water Commission-Board Member-Hecker Seat.

Douglas Van Buren made a motion seconded by Gary Wittenauer to approve the treasurer’s report and pay all bills submitted for the month of November. Voting all ayes, motion carried.

Mayor’s Report: President Kujawski left notes stating that the Hecker Code and Ordinances are now available to view online.

Also reminded us that Village Attorney Myron Hanna will be retiring at the end of the year and has handed out information on a possible replacement candidate. Terry Bruckert has been recommended by Charles Kujawski and by Myron Hanna.

Committee Reports:

Streets: Washington Street repairs have been completed. The Culvert on 281 W. Washington will need to be repaired where Reliable Trash backed over it.

Zoning: Wade Harrelson had a resident ask about the use of a portable container.

A new Contract with Reliable Sanitation was handed out to look over and vote on. James Mueth made a motion seconded by Gary Wittenauer to approve Resolution R-03-2022 to enter into a Contract with Reliable Sanitation for Trash and Recycling Collection Service. A roll call vote was taken:
