ORDINANCE NO. 20- 004

**AN ORDINANCE REVISING RATES FOR WATER SERVICE AND FOR  
SEWER SERVICE FOR CUSTOMERS INSIDE AND OUTSIDE OF THE  
VILLAGE OF HECKER, ILLINOIS**

**BE IT ORDAINED** by the President and Village Board of Trustees of the Village of Hecker, Monroe County, Illinois, as follows:

WHEREAS, the Village of Hecker, County of Monroe, State of Illinois, is authorized and empowered by the Constitution and Laws of the State of Illinois; and

WHEREAS, the Revised Code of Ordinances of Hecker, Illinois provides at Section 38-4-12 certain rates for water service for customers of the Village, effective as of **January 1, 2020** pursuant to adjustment as provided by ordinance, as follows:

**38-4-12      WATER RATES.**      There shall be established the following rates and charges for the use of the water system of the Village, based upon the amount of water consumed, as follows:

- (A)      **WATER SERVICE- INSIDE VILLAGE LIMITS**  
\$8.15 Minimum for the first 1,000 gallons per month  
\$4.73 per 1,000 gallons over 1,000 gallons
- (B)      **WATER SERVICE-OUTSIDE VILLAGE LIMITS**  
\$9.20 Minimum for the first 1,000 gallons per month  
\$5.79 per 1,000 gallons over 1,000 gallons
- (C)      **WATER SERVICE-MAPLE LEAF SUBDIVISION**  
\$9.20 Minimum for the first 1,000 gallons per month  
\$5.79 per 1,000 gallons over 1,000 gallons  
\$25.00 per month as repayment of Environmental Protection Agency loan authorized by Ordinance 02-03; and

WHEREAS, the Revised Code of Ordinances of Hecker, Illinois provides at Section 38-4-23 certain rates for sewer service for customers of the Village, effective as of **January 1, 2020** pursuant to adjustment as provided by ordinance, as follows:

**38-4-23      USER RATES.**      The following user rate is hereby established the use of and for service supplied by the Wastewater Facilities of the Village to-wit:

\$4.73 Minimum for the first 1,000 gallons per month  
\$3.15 per each 1,000 gallons over the first 1,000 gallons

The minimum charge of Four Dollars Seventy-Three Cents (\$4.73) monthly shall be applied to all users whose water consumption does not exceed one thousand (1,000) gallons monthly.

All non-metered residential users of wastewater facilities shall pay a minimum flat rate charge of \$15.77 per month, except in the event that use of wastewater facilities is determined by the Superintendent to be in excess of one thousand (1,000) gallons monthly, the Superintendent may require such flat rate user to install metering devices on the water supply or sewer main to measure the amount of service supplied; and

WHEREAS, the corporate authorities have determined that the rates charged by the Village for water service and sewer service must, in the best interest of the Village, be increased for all customers of the Village.

NOW, THEREFORE, be it ordained by the President and Board of Trustees of the Village of Hecker, Monroe County, Illinois, as follows:

SECTION 1: Section 38-4-12 of the Revised Code of Ordinances of Hecker, Illinois is hereby amended as follows:

**38-4-12      WATER RATES.**      There shall be established the following rates and charges for the use of the water system of the Village, based upon the amount of water consumed, as follows:

- (A)      **WATER SERVICE- INSIDE VILLAGE LIMITS**  
\$9.37 Minimum for the first 1,000 gallons per month  
\$5.44 per 1,000 gallons over 1,000 gallons
- (B)      **WATER SERVICE-OUTSIDE VILLAGE LIMITS**  
\$11.04 Minimum for the first 1,000 gallons per month  
\$6.94 per 1,000 gallons over 1,000 gallons
- (C)      **WATER SERVICE-MAPLE LEAF SUBDIVISION**  
\$11.04 Minimum for the first 1,000 gallons per month  
\$6.94 per 1,000 gallons over 1,000 gallons  
\$25.00 per month as repayment of Environmental Protection Agency loan authorized by Ordinance 02-03.
- (D)      The water rates established by this Section for use of water services provided by the Village shall be effective as of January 1, 2021. Such rates shall then be adjusted effective as of January 1 of each calendar year thereafter to effect an increase of two percent (2.0 %) over the respective water rate applicable for the calendar year immediately prior to such increase. However, the monthly repayment amount for the Environmental Protection Agency loan which is applicable to the Maple Leaf Subdivision shall not be subject to this automatic increase provision.

SECTION 2: Section 38-4-23 of the Revised Code of Ordinances of Hecker, Illinois is hereby amended as follows:

**38-4-23      USER RATES.**      The following user rate is hereby established the use of and for service supplied by the Wastewater Facilities of the Village to-wit:

\$4.83 Minimum for the first 1,000 gallons per month  
\$3.22 per each 1,000 gallons over the first 1,000 gallons

A minimum charge of Four Dollars Eighty-Three Cents (\$4.83) monthly shall be applied to all users whose water consumption does not exceed one thousand gallons monthly.

All non-metered residential users of wastewater facilities shall pay a minimum flat rate charge of \$16.08 per month, except in the event that use of wastewater facilities is determined by the Superintendent to be in excess of ten thousand (10,000) gallons monthly, the Superintendent may require such flat rate user to install metering devices on the water supply or sewer main to measure the amount of service supplied;

The rates established by this Section for use of wastewater facilities provided by the Village shall be effective as of January 1, 2021. Such rates shall then be adjusted effective as of January 1 of each calendar year thereafter to effect an increase of two percent (2.0 %) over the respective wastewater facilities rate applicable for the calendar year immediately prior to such increase; and

SECTION 3: The revised rates provided by this Ordinance shall become effective as of January 1, 2021.


SECTION 4: All ordinances, resolutions, and orders, or parts thereof, in conflict herewith, are hereby repealed.

SECTION 5: This Ordinance shall be in full force and effect, except for the effective date of the revised rates, immediately upon its adoption, approval, and publication, as provided by law.
